**Treasurers Report**

It was reported that MEHA is in excellent financial condition. M/S/P Larson/Carlton to approve the report to date.

**Committee Reports**

*History:* Manny Camilon reported that the committee has begun planning for MEHA's 50<sup>th</sup> anniversary activities. Let him know if you are interested in being on the planning committee.

*Legislative:* President-Elect Hibberd asked the membership for help in filling the position of Committee Chair. This committee will be tied into the marketing and outreach efforts over the next year.

**Strategic Plan**

President-Elect Hibberd reported on the strategic plan. The four goals are:

4. Be proactive in emerging environmental health issues.

### **Incoming Presidents Address**

Joe Hibberd presented a SWOT (Strengths, Weaknesses, Opportunities and Threats) assessment of MEHA. Our strengths include over 350 members, financial stability, active and vibrant Board of Directors and committees and recognition in the public health community in Minnesota as an equal partner. Our weaknesses include shifting priorities with changing leadership, dependency on employers to allow us to participate in MEHA meetings and conferences and the lack of unlimited funding. Our threats include scaling back or eliminating environmental health staff and the competition for resources.

During the next year, MEHA will be working to make our profession **VISIBLE**. We will have an active Publicity and Marketing Committee to get the word out about environmental health. We will have an active Outreach Committee to contact our partners in public health. We will continue to provide quality educational programs to our members and we will work toward professional recognition and visibility.

Renewals have been distributed quarterly. There has been a slight decrease in membership. The Committee recruiting activities during the year included personal contact with prospective new members. ## **Scholarship Committee**

The Mary Lauren Olson Scholarship Committee has had a good year.

### 2009 Scholarship:

The scholarship committee awarded the 2009-2010 Mary Lauren Olson Scholarship to Ms. Elizabeth Gaston, a Master's Degree student in the University of Minnesota's School of Public Health, Division of Environmental Health Sciences. Elizabeth is pursuing a Master's Degree in Infectious Disease. This year the award was \$1500.00. She attended and was introduced at the MEHA winter conference on January 14, 2010 in St. Cloud. An article about Elizabeth was submitted and printed in the MEHA Spring newsletter.

### Fund Balance:

Since 2008, we have received annual fund balance statements from MMF (Minnesota Medical Foundation- who manage the scholarship fund for MEHA) thru December 31 each year. As of this date, we have not received a statement for 2009 from MMF. The fund balance as of 9-30-2009 was \$33, 380.96. The spendable amount available, before issuing this year's \$1500 scholarship, was \$2188.95.

### Golf Tournament:

The 2009 annual Golf Tournament at Breezy Point, Brainerd brought in \$1235.00. There was \$960.62 spent for golfing fees and prizes. The net income was **\$274.38** for the 2009 golf tournament.

### Raffle:

The Scholarship raffle, also held during the MEHA Spring conference at Breezy Point in May 2009, was very successful. The committee supplied a number of prizes and we solicited donations from the MEHA general membership and received a number of lovely gifts. The revenue generated was **\$543.00!**

### Spring Conference Booth Fees:

The Mary Lauren Olson Scholarship receives ½ of any fees collected from the MEHA Spring Conference Booth Rentals (see the MEHA Policy and Procedure Manual, section 31.03) as a regular source of scholarship revenue. We received **\$375.00** in 2009 from MEHA for ½ booth rental fees.

### Scholarship Committee

The scholarship committee consists of Carlota Medus, Chair; Kris Lee; and Steven Roy. Steve Roy will step down from the committee after this year's spring conference. We thank Steve for his service to the Committee and MEHA these past 5 years. Steve has done a terrific job arranging and running the annual golf tournament. (He's also a great MC). Ms. Jill Debrito, MDH has agreed to join the scholarship committee and will be helping out with this year's tournament and officially starting in September 2010.
